## 20-hour training for Child Custody Evaluators and Mediators

#### Beginning/Intermediate

Description: This 20-hour course combines 12 hours of basic instruction in custody evaluation standards of practice and procedures, ethical issues, investigation strategies, legal requirements, use of psychological testing, effects of child abuse and domestic violence on parenting and on child development, and preparation for testifying in court, with 8 hours of advanced training in cutting-edge issues that child custody evaluators and mediators grapple with in their practices. This course satisfies CA state requirements for 20 of the 40-hour initial training for all Custody Evaluators and Mediators [C.R.C.# 5.210(f), 5.220(g), 5.225(d), & Family Code §§1815, 1816, 3110.5(b)(2)].

**Continuing Education:** Up to 20 hours CE credits for Psychologists, MFTs, LCSWs, Counselors, Nurses, Attorneys, Mediators and Child Custody Evaluators

## 2. Abused Kids with Disabilities: A National Training & Support Project – 2 Days

#### All Levels

Description: Trauma is already a major issue for children who are abused, but this is compounded when they also have disabilities. Children who acquire disabilities as a direct result of abuse are also more likely to experience multiple types of maltreatment and trauma. This training will teach specialized approaches to use during the crisis of a child abuse call and afterwards when the victim has a disability.

This is a specific training for first responders, victim advocates, mental health, social service, and allied professionals on the dynamics and complexities of abuse and disabilities, as well as the techniques needed in dealing with such cases, interviewing the victims, and working in collaborative teams.

## Note: Attendance at the second day requires the first day or equivalent training

## 3. Investigation and Prosecution of Child Abuse Cases – 2 Days

#### Intermediate

Description: This course is designed for law enforcement officers, prosecutors, child protection workers, forensic interviewers or other child protection professionals participating in a multidisciplinary response to allegation of child maltreatment. Attendees will learn practical skills in crime scene investigation, suspect interrogation, trial skills (cross examination, opening statements and closing arguments), and cultural sensitivity before, during and after the forensic interview. Attendees will also receive instruction on emerging issues including the investigation of sexual abuse involving pre and non-verbal children, and vicarious trauma.

This session will involve three presentations addressing trauma and intimate partner violence victims. #### P3 Ethical & Legal Issues in Mental Health Practice

#### Intermediate/Advanced

This workshop focuses on advanced ethical practice for mental health practitioners, describing enforceable standards and aspirational principles for mental health professionals. The presentation emphasizes: (1) five general principles that are relevant to all mental health professionals; (2) an ethical decision-making process when faced with potential ethical, legal, clinical dilemmas; and (3) those specific ethical principles in which mental health professionals are accused within civil lawsuits, ethics and licensing board complaints. Consultation, record keeping and informed consent are also discussed. A section of this presentation focuses on high risk clinical situations, high-risk patients, with examples from malpractice cases filed against mental health professionals. Another section focuses on mismanagement and courtroom processes (such as negligence that often emerges during malpractice legal cases) and standards of care. There will be a section on ethical issues faced by clinical supervisors and ethical and legal issues commonly faced within academic institutions. There will also be a discussion of HIPAA, evaluating dangerousness, and the need for professional boundaries.

## P4 The Collaborative Stage Model: A Blueprint for Healing from Complex Trauma
