REPORT OF AFBAH EVENTS

A Meeting for Professionals on June 14, 2006: The Link is You!

"You're the link, not the binding link, but the liberating link!" said Geneviève Laroque, FNG (Fondation Nationale de Gérontologie) president and AFBAH vice-president. Part of professionals surrounding elderly persons, respecting elderly persons's desire and wishes, were the subjects of this meeting. More than 150 professionals (from information centres, elderly persons's homes, hospitals, home help...) were present, as the television (France 3) coverage of the event aired on the regional news June 15th.

The AFBAH presented a guide for caregivers (work in progress). A test version has been put on the website. This guide presents activities for caregivers in Paris and suburbs.

A theatrical company (la compagnie Berlingot) played scenes on autonomy, family links difficulties, elderly persons and professional caregivers relations, and teleassistance (help service using a telephone). The audience could come on stage to modify each scene (Augusto Boal's oppressed theatre). This kind of performance is an excellent sensitizing tool. The actors quality and pertinent dialogue made it more effective. The well-mastered humorous aspect permitted audience agreement.

The part on Teleassistance emphasized the social circle as crucial to detecting mistreatment and on what can be done to acknowledge its importance. Another part presented the practical aspect of organizing talk groups for caregivers, difficulties expressed, the kind of people taking part, help and information.

To conclude, Geneviève Laroque expressed the idea "you're the link, not the binding link, but the liberating link." She reminded everyone that if an old person preferred apple pie than strawberry pie, than to give apple pie was more "welltreating" even if it was a frozen product and even if strawberry pie was home made and healthier (joke based on the play).

INPEA FLAG PLANTED FIRMLY IN AFRICA

A frica is a vast continent, made up of 56 countries – according to the United Nations Population Division (2006), including adjacent islands. How to liase with numerous individual and organizational members across the region, and to co-ordinate anti-elder abuse activities regionally, posed an enormous challenge for INPEA Africa 18 months ago. A decision was taken therefore to encourage countries in which a focal person could be identified, to mobilize members, constitute a country chapter, apply for membership of INPEA and elect a National Representative. The Regional Representative for Africa would then liaise with national representatives, who in turn should liaise with members of their chapter. In the 18 months, seven countries thus far have formed INPEA chapters. The countries and the names of the national representatives, whom I now introduce you to, are Cameroon (Prince Bengha Martin), Ghana (Ebenezer Adjetey-Sorsey), Mauritius (Mahendranath Busgopaul), Nigeria (John Francis Fagjot), South Africa (Pat Lindgren), The Gambia (Priscilla Jones) and Uganda (Semanda Richard).

Africa's national representatives are hardworking, dedicated and creative, and regularly turn in reports on activities and inroads made in the fight against elder abuse in their country to the regional office (the office is currently based in Cape Town, South Africa). Their reports on activities held to mark WEAAD 2006 were especially interesting and impressive, as were the numerous, colourful photographs that accompanied the reports, all of which have been archived, after being shared with INPEA members.

Some African country chapters are particularly active – notably Nigeria, Cameroon and Uganda, and have submitted reports recently, with documentation, on successful approaches made to government departments to elicit formal attention to broad and specific issues and concerns of older persons, among which are abuse and exploitation, and discrimination and marginalization. Older persons' vulnerability and victimization, and violation of their rights, are highly charged political and emotive issues in African societies. How the chapters approach their government to advocate for attention to injustices and the scourge of elder abuse, by piggy-backing on

broader issues of poverty, housing and health care for older persons, offers an interesting perspective and an apparently effective approach.

Seven out of 56 still leaves a large number of African countries in which a key person needs to be identified and encouraged to form an INPEA chapter. INPEA members everywhere, who may know of such persons in other African countries, are invited to help us to identify and approach them. Anyone interested in obtaining additional information on INPEA Africa or member countries' activities is warmly invited to contact me.

LETTER FROM KOREA

Dear All,

Privately I am very happy that our world has tried to make people recognize elder abuse. There has been a concern form government, NPO and mass media in Korea. It has taken 10 years after presenting the first Doctor thesis about elder abuse in Korea by me in 1996.

It will be together will all generations, Ministry of Social Welfare, Korean Medical Association, Korean Gerontological Society, Busan daily newspaper and so on. There will be social drama about elder abuse we find and to recognize what elder abuse is. We are all together in that day. Especially we will advertise to mass media, and mass media will help us spread the main purpose of world elder abuse awareness day.

Also there will be a center for prevention of elder abuse in Seoul Korea starting next month, and will be funded by government. It is a great development. From this point on our Korean society will have efforts made for the prevention of elder abuse. Our KINPEA (Korean Information Network for the Prevention of Elder Abuse) will also try to give lots of information and develop and empower the older person in Korean society.

US Administration on Aging, Reaches Out Locally, Nationally, and Globally

In the lead up to World Elder Abuse Awareness Day, the US Administration on Aging through the National Center on Aging (NCEA) a "World Elder Abuse Awareness Day Partner" rallied to the call of the National Committee for the Prevention of Elder Abuse, (NCPEA), and pledged \$10,000 in support for awareness raising events in the US. The funds were utilized by NCPEA for a Web-based event to tout World Day and encourage grass roots involvement. Thereafter, 12 mini - grants were awarded to organizations around the USA for grassroots outreach aimed at raising public awareness and understanding of elder abuse. WEAAD became a rallying point for reaching out locally, nationally, and globally. There's no question that a little seed money did go a long way.
